INTRODUCTION

This document provides the structure for the ACAPS Ukraine regional dataset. The regional dataset aims to help the humanitarian community understand the Ukrainian refugee crisis in the countries where refugee movements have had an impact after 24 February 2022. Having reviewed a number of preliminary indicators, the ACAPS Ukraine hub analysts preselected six countries for comparison. These countries are Czechia, Hungary, Moldova, Poland, Romania, and Slovakia (referred to as the countries of the region or the host countries). The dataset will map the host country's capacity to host Ukrainian refugees, mapping the scope and scale of international displacement and the vulnerabilities of those affected. Consolidated data will allow a comparison of Ukrainian refugees' humanitarian situations across the countries. The analysis uses demographic, socioeconomic, humanitarian, and crisis impact frameworks. The dataset puts together a variety of indicators using data from national governments, the UNHRC, IOM, and external sources, as well as internal ACAPS calculations based on open-source data.

METHODOLOGY

ACAPS data collectors, trained on the organisation's methodologies and indicators, monitor the situation in the relevant regions and updated the indicators, inputting applicable data under the applicable indicators. The period covered is from the beginning of the refugee crisis after the launch of the Russian invasion of Ukraine in February 2022. ACAPS collected data from May–June 2023 and will continue to update the indicators when possible. After the indicators are updated, analysts with contextual knowledge conduct a quality review of the data, made available through our Application Programming Interface (API).

The dataset is also published in CSV format.

ACAPS will release the first-tier dataset in July 2023; updated versions will be published when comparable data is available.

SOURCES

ACAPS sources data from publicly available information, such as reports from international and local humanitarian organisations, international and local media, social media platforms, UN agencies, and official government websites. When deciding what data to include in the dataset, analysts apply analytical judgements. Some indicators rely on fixed sources, as outlined in the indicators list.

LIMITATIONS

ACAPS relies on open sources and the expert judgement of trained data collectors in selecting the most reliable sources. ACAPS has an operational presence, but we do not undertake primary data collection exercises, meaning we do not have control over the collection of primary data. Data collectors have various language skills, but linguistic barriers may prevent ACAPS from identifying all the available information.

Some indicators include data from UNHCR Protection Monitoring, Multi-Sectoral Needs Assessment, and joint UNHCR and REACH Profiling Updates, where results are indicative and reflect the perception and interpretation of the respondents only at the time of the data collection from the interview. Although these reports randomly select respondents to reduce bias, they use non-probability sampling, and results cannot necessarily be extrapolated across the population of Ukrainian refugees.

ANALYSIS FRAMEWORK

ACAPS has identified 12 pillars to track the humanitarian situation regarding the Ukrainian refugee crisis in the region over time. Each pillar contains a variety of indicators, as outlined below. Please note that the list is not exhaustive and is open to additions.

Baseline demography	This pillar provides basic demographic information on the countries hosting Ukrainian refugees, minorities, and foreigners.
Socioeconomic situation	This pillar covers the basic socioeconomic indicators of the host countries.
Humanitarian response capacity	This pillar covers the scope of national allocation to support refugees in the host countries.
Crisis impact- Refugees profiles	This pillar provides information about refugee profiles in the host countries.
Crisis impact- Displacement situation	This pillar covers the number of refugees reporting intentions to return.
Crisis impact- Assistance	This pillar covers the number of refugees registered for UNHCR cash assistance.
Crisis impact- Legal status	This pillar covers the number of refugees reporting awareness gaps regarding their legal situation and rights in the host countries.
Crisis impact- Health	This pillar covers the healthcare needs of Ukrainian refugees in the host countries.
Crisis impact- Accommodation	This pillar covers the situation of refugees residing in private or paid accommodations or collective centres.
Crisis impact- Education	This pillar covers the number of children enrolled in schools in the host countries and the education levels of refugees before relocation.
Crisis impact- Employment	This pillar covers the employment of Ukrainian refugees in the host countries.
Crisis impact- Social cohesion	This pillar covers the attitudes towards Ukrainian refugees in the host countries.

Dataset structure and indicators

Where the dataset contains figures or empty fields, no information is available.

The dataset is released in four components:

- 1. log, which contains the actual data points
- 2. quantitative indicators report, which contains the value per indicator
- 3. qualitative repository, which contains a repository of thematic qualitative information
